ELIGIBLE EMPLOYEES MUST BE HIRED BY MARCH 31ST OF THE CURRENT FISCAL YEAR. THE BONUS PAYOUT TOTAL IS APPROVED BY THE BOARD EACH YEAR WITH CONSIDERATION TO FUNDING AVAILABILITY. THE FINAL BONUS PERCENTAGES ARE APPLIED TO THE EMPLOYEE'S ANNUAL SALARY FROM THE PRIOR YEAR. BONUS PAYOUTS ARE ISSUED THROUGH PAYROLL IN THE FIRST QUARTER OF THE CALENDAR YEAR.
